Historically, the promotion of wills and trusts for tribal members has received little attention by federal and tribal governments. This training session will examine complex issues facing tribal and BIA officials in dealing with Indian probate, estate planning and will drafting. This course also addresses important changes in Indian probate law and the Indian Land Consolidation Act.

### **Tools for Resolving the Complex Issues of Indian Probate Matters!**

This training will be conducted December 4-6, 2013, at the Flamingo Hotel & Casino, Las Vegas, NV. This course is designed for tribal government and BIA personnel involved in Indian Probate matters. It is also recommended for tribal members who want to plan their estates independently. This session examines complex problems concerning Indian decedents and the distribution of personal and real property and provides explanation of legal definitions, principles and case law.
