The California Nevada Tribal Transportation Training and Technical Assistance Program (CA/NV TTAP) invites you to attend the Bureau of Indian Affairs (BIA) Roads Inventory Field Database System (RIFDS) Training.

The RIFDS was developed according to regulations in 25 CFR part 170, and is an Internet Based System that manages the Indian Reservation Road (IRR) Program Inventory Data and is accessible from the field, both at the BIA Regional level and the Tribal level.

The first day of training will focus on overview of the RIFDS system. The second day training will familiarize you with the RIFDS system and include hands on computer training on the RIFDS system.

If you become certified to use the RIFDS system at this session and passing a federal background check using forms to be provided at this session, your tribe will have the capacity to enter and manage its own road data which governs the IRR funding stream for your tribe.
