TRAINING SUMMARY

The California and Nevada Tribal Transportation Training and Technical Assistance Program (CA/NV TTAP) invites you to attend a **CalTrans Encroachment Permit Training for California Tribal Communities**.

The use of California State highways for other than normal transportation purposes may require written authorization from the Department of Transportation. As the responsible Department for protecting the public's investment in the State highway system, CalTrans reviews all requests from tribal communities, construction companies, utility companies, developers, volunteers, nonprofit organizations and others desiring to conduct various activities within CalTrans right of way. Such activities could include for example: construction of highway improvements, driveway installation and maintenance, highway landscaping and graffiti removal, commercial filming, special events such as parades commemorating an event, e.g. Independence Day.

As California tribal communities continue to grow and develop, it is important for us to be informed about the state encroachment permit process, when encroachment permits may be required and the timeframes for obtaining an encroachment permit.
